## **PUBLIC NOTICE**

Commissioner Jean-Pierre L. Oriol of the Department of Planning and Natural Resources informs the public that the following St. John CZM Committee Meeting is scheduled for Thursday, May 20, 2021 at 4:00 pm. In an effort to help to reduce the global spread of the coronavirus (COVID-19), this meeting will be held via the video conferencing platform Zoom.

The agenda is as follows:

### ***Decision Meeting (Public testimony will not be heard) - TENTATIVE***

Lovango Island Holdings, LLP (Major CZM Permit No. CZJ-02-21(L)) proposes to modify the existing permit to allow for the following changes to the original plan: (a) the differentiation of the tent product (previously 15) into (8) tents & (7) tree houses; (b) minor relocating of the tents and tree houses within the same zone; (c) the addition of a staff apartment above the proposed pump house; (d) revisions to the kitchen layout and future staff house; (e) the expansion of the retail village to include some of the functions of the proposed reception building; and (f) a reduction in size of the reception building.

### ***Public Hearing (Public testimony will be heard):***

National Park Service (Federal Consistency Determination No. CZJ-04-21(FC)) proposes to renovate the existing visitor center, repairing the components damaged by the 2017 storms and make the building more resilient to future storms and sea level rise. NPS has also requested permission to repair the aging bulkhead and dock; and to conduct maintenance dredging of the basin within the National Park Service's control to allow ample depth for the docking of their vessels. The project site is located at the NPS Cruz Bay Visitor Center Plot No. 12 Estate Caneel Bay, St. John, US Virgin Islands.
