PUBLIC NOTICE

Commissioner Jean-Pierre L. Oriol of the Department of Planning and Natural Resources informs the public that the following St. Croix Coastal Zone Management (CZM) Committee Meeting is scheduled for Tuesday, November 23, 2021, at 4:00 pm. In an effort to help to reduce the global spread of the coronavirus (COVID-19), this meeting will be held via the video conferencing platform Zoom.

The agenda is as follows:

Decision Meeting

Federal Consistency Determination No. CZX-5-21(FC), the Governor Juan F. Luis Hospital & Medical Center is proposing to undertake multiple FEMA-funded projects that would support the stabilization of the only hospital system on the island of St. Croix, through the construction of an interim hospital and support utility systems. The various projects include the construction, demolition, earth change, soil boring, electrical, plumbing, paving, mechanical piping trenching, and generator installations on various sites of the JFL campus. The project also includes two additional sections of land to provide additional placement options for the temporary facilities. The proposed project site is located at Plot No. 4007 Diamond Ruby, St. Croix, Virgin Islands, with additional acreage to the south and east of the main campus.

Public Hearing (public testimony will be heard):

Federal Consistency Determination No. CZX-1-22(FC), the Virgin Islands Department of Agriculture is proposing to demolish the Administration Building and combine the program components of the existing Administration and Forestry Buildings into one replacement building in order to service the current and future needs of VIDIA. The proposed project site is located at Parcel No. 1 of Estate Lower Love, Prince Quarter, St. Croix, Virgin Islands.
