PUBLIC NOTICE

Commissioner Jean-Pierre L. Oriol of the Department of Planning and Natural Resources informs the public that the following St. John CZM Committee Meeting is scheduled for Thursday, August 18, 2022, at 4:00 pm. In an effort to help to reduce the global spread of the coronavirus (COVID-19), this meeting will be held via the video conferencing platform Zoom.

The agenda is as follows:

Public Hearing (Public testimony will be heard):

Virgin Islands Department of Human Services (Federal Consistency Determination No. CZJ-02-22(FC)) proposing the complete demolition/removal of buildings and support structures in preparation for the construction of a new facility. The existing infrastructure suffered major damage during Hurricane Irma in September 2017 and will be demolished/removed and replaced through funding provided by the Bipartisan Budget Act of 2018 (Feb. 9, 2018). The proposed design includes 2 buildings, one of approximately 1,695 square feet and the other of approximately 1,230 square feet; 8 parking spaces including 1 for handicap; a playground area; a utility yard to accommodate a septic tank; a power generator and a cistern. The proposed project is the initial step in expanding the services provided by the department's Head Start & Early Head Start Program on the island of St. John. The project is located at Estate Contant & Enighed, St. John.
