System for Award Management (SAM) Registration

IMPORTANT!! This is a Federal Website and it is FREE!!! Thus, please ensure you are on the correct website before engaging to accepting any solicitations!

In an ongoing effort to properly manage Disaster Recovery Funding and to improve our processes to benefit the People of the Virgin Islands, the Department of Property and Procurement is pleased to announce that the Government, through the Department of Property and Procurement is currently implementing new process updates to its Vendor Maintenance System. As such, all vendors doing business with the Government are required to submit all of their business documents and current System for Award Management/Sam.Gov registration to obtain and maintain a vendor number with the Government of the Virgin Islands.

I. REGISTERING WITH SAM.GOV

In order to register with Sam.Gov, vendors must know their Company's Data Universal Numbering System ("DUNS") ID number. The greatest benefit of establishing a DUNS number for your business is that anyone seeking to better understand your business' credit history and creditworthiness will likely look to Dun & Bradstreet to find this information. Businesses that contract with government agencies are required to have a DUNS number. If your company does not have a DUNS number, you will be required to acquire one.

Registering with SAM.Gov entitles your business to do business with the United States Government and the Virgin Islands Government. The Virgin Islands Government is a substantial recipient of federal funds, and as a result, all of our vendors are required to register with SAM.Gov.



- ➤ Completed "Core Data" as follows:
- > Validate your Duns information (must be just how it is on the email received from D&B)
- Enter Business Information (Tax Identification Number, etc.)
- ➤ Enter your CAGE code if you have one, if not one will be assigned after your registration process is completed.
- Enter your General information (Business Type, Organization Structure, etc.)
- Enter Financial information (Bank routing number, Account number, Type of account, etc.)
- Completed Executive Compensation
- > Completed Proceeding Details
- > Completed Assertions to include:
- Goods & Services (NAICS, PSC, etc.)
