Oriol of the Department of Planning and Natural Resources informs the public that the following St. John Coastal Zone Management (CZM) Committee Meeting is scheduled for Wednesday, May 24, 2023, at 4:00 pm. In an effort to help to reduce the global spread of the coronavirus (COVID-19), this meeting will be held via the video conferencing platform Zoom.

The agenda is as follows:

*Public Hearing (public testimony will be heard)*

Federal Consistency Determination No. CZM0004-23 has been submitted by the Virgin Islands Department of Agriculture. The FEMA funded project proposes installing a temporary modular building with all related appurtenances. The proposed project site is located at #11 Estate Carolina, St. John, Virgin Islands.

Federal Consistency Determination, CZM0006-23, has been submitted by the Federal Highway Administration in cooperation with the National Park Service. The project proposes to repair storm damage along the Lyne House Access Road. The proposed project site is in the Virgin Islands National Park along Route# 0413, St. John, Virgin Islands.
